Directions For Use

Vacuum carpet thoroughly. Test carpet for colorfastness in an inconspicuous area before any method of cleaning. First Method: For lightly soiled carpets, dilute 2 ounces per gallon of water, for medium soiled carpets dilute 3 ounces, for heavily soiled carpets dilute 4 ounces. Follow up after extraction by using a Rinse & Neutralizer as per directions on label. Second Method: Spray diluted product, as per first method dilution ratios, onto the carpet allowing to dwell 3-5 minutes, then proceed to rinse using a Rinse & Neutralizer as per directions on label. To control excessive sudsing during extraction caused by prior cleanings,

use a Defoamer in the recovery tank of the extraction machine. CAUTION: Do not overwet carpet. Release the solution out and make only one pass with the extraction machine. Be certain to overlap 1-2 inches. This method will prevent overwetting. The carpet should be dry within 4 hours. Use fan if necessary.
